**Re: Curbside Management Adjustments at 2111 Decatur Place NW**

Chairperson Warren,

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

### **EXECUTIVE SUMMARY**

DDOT will replace a No Parking Entrance zone with metered parking in the 2100 block of Phelps Place. DDOT will relocate and reprogram the No Parking Entrance zone in the 2100 block of Decatur Place to facilitate 24-hour passenger loading.

### **DETAIL PROPOSED ACTIONS**

2100 block of Phelps Place- DDOT will remove the No Parking Entrance zone per request of the Friends Meeting of Washington DC (2111 Decatur Place NW). This zone was previously used for loading of passengers with disabilities, but the space is no longer needed after recent renovations to the building. Additionally, this zone was generally not conducive to loading of passengers with disabilities due to the steep grade of the sidewalk and roadway. The zone will revert to metered parking consistent with the adjacent curbside.

2100 block of Decatur Place- DDOT will relocate the ~23-foot No Parking Entrance zone in the 2100 block of Decatur Place adjacent to 2111 Decatur Place NW. The zone will be replaced by an extension of existing 2-hour parking (7am-6:30pm, Monday-Friday). A new ~42-foot No Parking zone will be installed east of the 2-hr parking zone to facilitate passenger loading near the accessible entrance at 2111 Decatur Place NW.

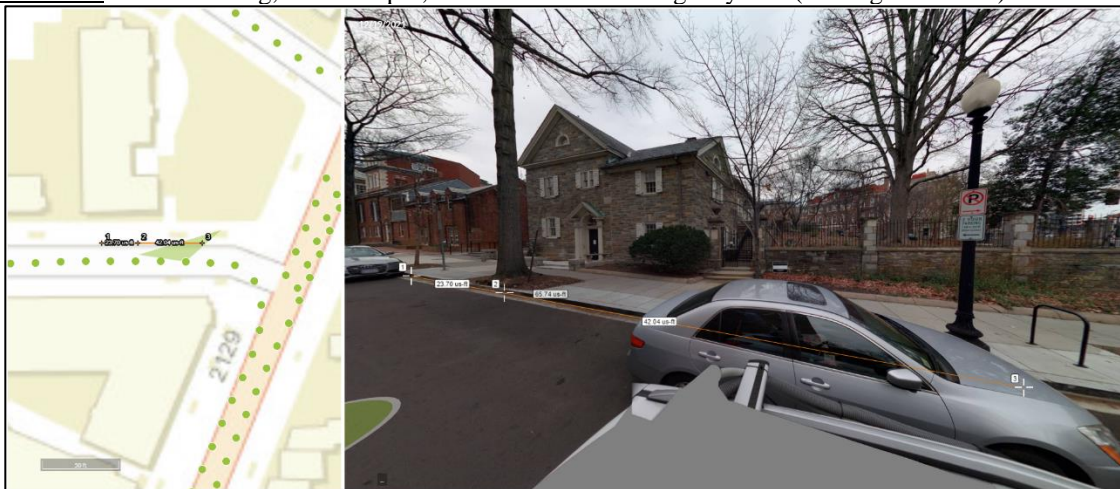
### 2100 block of Phelps Place NW
