Yes. Resumes for Key Personnel are mandatory as they form part of evaluation. You may attach resumes of other support staff above, however, keep in mind the individual section page limits and overall page limits of SF330 as detailed out in para 8 of issued RFQ.
Can the organization chart be 11x17”?	Yes.
Is proof of firm DBE certifications required to be included in our proposal response?	Yes.

Replacement is for whole section 4. mentioned in the original RFQ issued with what mentioned in Amendment 1 and mentioned herewith again below: DISADVANTAGED BUSINESS ENTERPRICE (DBE) GOAL <i>A 20% DBE subcontracting goal for firms certified as DBEs in accordance with Title 49, Subtitle A, Part 26 of the CFR has been established for this federally assisted contract. The contract will be subject to all applicable Federal regulations including Title VI of the Civil Rights Acts of 1964.
