Parking Removal at 12th Street and Franklin Street NE

Dear Chairperson Carley:

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction.

- Remove three (3) non-permit parking spaces on 12<sup>th</sup> Street NE in advance of the signalized intersection of 12<sup>th</sup> Street and Franklin Street NE. The parking removal will facilitate the installation of a northbound left turn bay, improving transit operations at this location.
- Remove three (3) non-permit parking spaces on 12<sup>th</sup> Street NE north of the signalized intersection of 12<sup>th</sup> Street and Franklin Street NE. The parking removal will facilitate the relocation of the northbound WMATA bus stop from the south side of the intersection to the north side.

Presently, parking is permitted on 12th Street NE in advance of Franklin Street NE between the midblock driveway and the WMATA bus stop. This segment of 12th Street NE is highly congested in peak hours due to high left turn volumes which results safety issues at the intersection and delays for transit users. In response to recommendations to improve the left turn operation as part of the Brookland-Edgewood Livability and Franklin Street Corridor Studies, removal of these non-permit parking spaces will permit DDOT to install a dedicated left turn bay to mitigate these issues to improve overall intersection safety and transit operations.

Parking is also permitted on 12<sup>th</sup> Street NE north of Franklin Street NE. Removal of three (3) parking spaces will facilitate relocation of the northbound near-side bus to stop to the far side of the intersection.
