### **Re: Bus Zone Expansion and Meter Removal at Farragut Square**

Chairperson Holden,

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

- Conversion of hourly metered parking to Metrobus Zone

#### **EXECUTIVE SUMMARY**

DDOT will change the curbside designation of the 900 Block of 17<sup>th</sup> Street NW in the southbound direction to expand the existing WMATA Metrobus Zone. This will remove six (6) hourly metered parking spaces.

#### **DETAIL PROPOSED ACTIONS**

WMATA requested the expansion of the Metrobus zone at Farragut Square to accommodate increase bus capacity. DDOT Transit Delivery and Curbside Management Division reviewed this area and determined that an increased bus zone could be accommodated. DDOT will change the curbside designation of the 900 Block of 17<sup>th</sup> Street NW in the southbound direction to expand the existing WMATA Metrobus Zone. This will remove six (6) hourly metered parking spaces. The MRV zone will also be removed to accommodate the new bus zone area.

#### **VISUAL AID**

This visual aid shows the curbside space that will be redesignated as Metrobus Zone outlined in orange.
