Re: United States Capitol Police – DDOT Signage Reconciliation

Dear Chairpersons Shankle, Holman, Wirt, and Daniels,

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

EXECUTIVE SUMMARY

DDOT will be reconciling its truck and bus roadway designations to coordinate with the Congress-mandated and United States Capitol Police (USCP) enforced Truck Exclusion Zone and diversion routes around the Capitol Complex.

DETAIL PROPOSED ACTIONS


In 2003, The United States Congress established a Truck Interdiction Program, which mandated that the United States Capitol Police (USCP) establish a Truck Exclusion Zone and diversion points around the Capitol Complex. The Truck Exclusion Zone encompasses approximate one-block radius around the Capitol building, bounded by 3rd Street to the west, D Street / Washington Street to the south, 2nd Street to the east, and Louisiana / C Street to the north.

The program has since evolved into the Truck Interdiction Monitoring Program (TIMP), which prohibits all heavy vehicles (trucks and buses) from entering its Truck Exclusion Zone and uses variable message boards to divert prohibited vehicles about one block before the zone boundaries. The program consists of: 1) static signage to identify the Truck Exclusion Zone, 2) traffic light interdiction buttons to support the safe deployment of inroad vehicle barriers, and 3) a network of closed-circuit video cameras to monitor traffic flow and increase situational awareness of interdiction officers. MP It is important to note that WMATA, MTA, and Circulator buses are exempted from this USCP TIMP prohibition; USCP permits them to continue traveling through the Truck Exemption Zone along their scheduled routes.

USCP conducted a Traffic Study and briefed DDOT on its recommendations to raise awareness of its Truck Exclusion Zone, increase transportation safety, and reduce the number of required vehicle interventions. This briefing clarified that USCP's designated diversion routes for prohibited vehicles around the Capitol Complex have been in conflict with DDOT bus and/or truck restrictions since the institution of the TIMP program in 2003.

As a result, DDOT will be reconciling its truck and bus roadway designations to coordinate with the Congress-mandated Truck Exclusion Zone and diversion routes around the Capitol Complex. As detailed below, this entails adjusting truck and bus routes and/or restrictions along several Capitol Hill roadways to reconcile DDOT's route system with the existing TIMP program, as mandated by Congress.
