Re: Installation of New High intensity Activated Crosswalk (HAWK) Signal and Median on Georgia Avenue NW at Hamilton Street NW Intersection

Dear Commissioners Mansaray and Bowser:

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

• Installation of New High intensity Activated Crosswalk (HAWK) Signal and Median on Georgia Avenue NW at Hamilton Street NW Intersection

Currently the Georgia Avenue and Hamilton Street NW intersection is controlled by stop signs on the eastbound and westbound Hamilton Street NW approaches. Gorgia Avenue approaches are uncontrolled.

A determination has been made by the DDOT/Traffic Engineering and Signals Division to install and operate a High intensity Activated Crosswalk (HAWK) signal at this intersection. HAWK signal control can provide for the safe and efficient movement of vehicular and pedestrian traffic operating through and in the immediate vicinity of this intersection. The proposed new HAWK signal will be timed to operate in harmony with adjacent traffic signals on the Georgia Avenue corridor to minimize disruptions to through traffic.

Additionally, DDOT determined that a central median consisting of flexible bollards along Georgia Avenue is recommended for implementation at the intersection to eliminate the angle crash pattern. Therefore, the following traffic movements will be restricted: all left turn movements from all approaches, and all through movements from the Hamilton Street NW approaches. Only right turn movements and through movements from Georgia Avenue approaches will be permitted.

Figure 1 illustrates the proposed median to be installed. Please note that the white arrows demonstrate the movement that will remain permitted at the intersection, upon completion of the median installation.

All comments on this subject matter must be filed in writing by (thirty days after the date of this notice), with the District Department of Transportation (DDOT), Project Delivery Administration at 250 M Street, SE, Washington, D.C. 20003. DDOT will review and evaluate comments and anticipates initiating implementation of the above-mentioned modifications starting at the end of the thirty business days, pending weather conditions.
