Re: Truck Access to Alley between 2100 blocks of K and L Streets NW

Dear Chairperson Causey,

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

EXECUTIVE SUMMARY

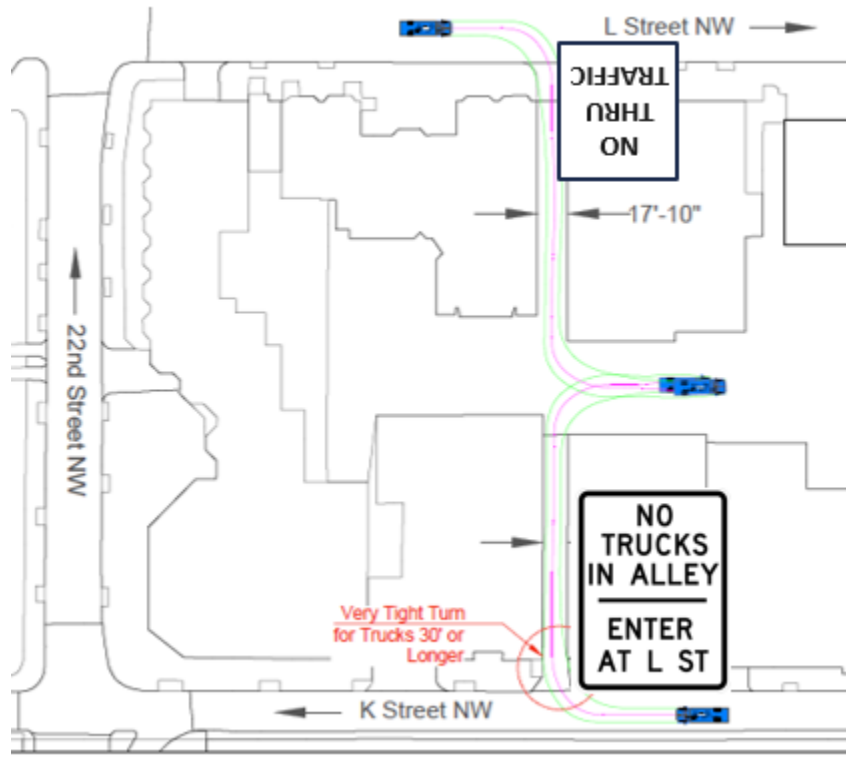
DDOT proposes to restrict truck access from the K Street entrance of the alley between the 2100 blocks of K and L Streets NW and direct them to exclusively use the L Street alley entrance. In addition, DDOT proposes to sign the L Street alley entrance as No Thru Traffic.

DETAIL PROPOSED ACTIONS

The alley between the 2100 blocks of K and L Streets NW is a two-way alley providing access to loading docks, garbage dumpsters, and parking garages for surrounding buildings. Passenger vehicles entering or exiting the 2131 K St parking garage via K Street must make a three-point turn, creating congestion in the alley. In addition, trucks turning east or west within the alley must make a three-point turn to reach loading docks or garbage dumpsters.

Based on community concerns about the aforementioned vehicle circulation and congestion issues within the alley, DDOT proposes to add a “No Trucks in Alley / Enter at L St” sign to direct trucks away from the narrower southern leg of the alley and prevent turning trucks from encroaching onto the K St sidewalk. In addition, DDOT proposes to add No Thru Traffic signage at L Street NW, where observed cut-through traffic entered in order to reduce and/or enable enforcement against cut-through traffic in the alley.
