**Re: New Through Trucks Over 1 ¼ Ton Capacity Restriction on Otis Street NE**

Dear Chairperson Higgins,

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

#### EXECUTIVE SUMMARY

DDOT proposes to restrict through trucks over 1 and ¼ ton capacity on Otis Street NE between 13<sup>th</sup> Street NE and South Dakota Ave NE in order to support the residential character of the neighborhood.

#### DETAIL PROPOSED ACTIONS

DDOT reviewed residential requests for through truck restrictions on the 1900 block of Otis Street NE. The agency collected vehicular volumes, speeds, and classification data obtained from January 19<sup>th</sup> to January 20<sup>th</sup>, 2022, for the 1900 block of Otis Street, E. In addition, the agency reviewed the roadway’s existing designations and restrictions, land use characteristics, functional classification, and circulation role through the larger roadway network to determine whether through truck restrictions might be appropriate. DDOT’s data found speeding & higher volumes of heavy vehicles on the eastbound direction of the roadway, which has a local functional classification, prompting DDOT to propose “No Through Trucks Over 1 ¼ Ton Capacity” restrictions on along the residential corridor of Otis Street NE between South Dakota Avenue and 13<sup>th</sup> Street NE.

Under these proposed restrictions, trucks over 1 ¼ ton capacity would not be allowed to cut-through the neighborhood en route to further destinations, but trucks making local deliveries would still be permitted.
