Re: Convert Unit block of Crittenden St NE to one-way Eastbound and Unit block of Buchanan St NE to One-Way Westbound. Install Southbound left-turn bay at Crittenden St NE

Dear Chairpersons: Edwards and Bowser

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCMR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

- **Installation of full time one-way Eastbound roadway on Unit block of Crittenden St NE.**
- **Installation of full time one-way Westbound roadway on Unit block of Buchanan St NE.**
- **Installation of short Southbound left- turn bay at North Capitol St NE and Crittenden St NE.**

This modification is a result of the analysis performed by DDOT in response to neighborhood traffic safety concerns for pedestrians and vehicular traffic safety.

Figure 1 and Figure 2 illustrates the proposed improvements.

All comments on this subject matter must be filed in writing by Thursday, June 22, 2022 (thirty business days after the date of this notice), with the District Department of Transportation (DDOT), Project Delivery Administration at 250 M Street, SE, Washington, D.C. 20003. DDOT will review and evaluate comments and make any necessary adjustments to the intersection following the implementation.
