Re: Lane reduction on northbound North Capitol Street between Longfellow Street NE/NW and McDonald Place NE, conversion of one (1) p.m. peak period travel lane to a full-time parking lane, and removal of Bus Stop ID 1002642.

Dear Chairperson Brooks,

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

- **Lane reduction on northbound North Capitol Street between Longfellow Street NE/NW and McDonald Place NE. Project involves conversion of one (1) p.m. peak period travel lane to a full-time (24-hour) parking lane, addition of signs, pavement markings, and removal of Bus Stop ID 1002642.**

Presently, North Capitol Street between Longfellow Street and McDonald Place NE has two (2) travel lanes in the northbound direction during the p.m. peak period (4:00-6:30 PM Monday-Friday) and (1) lane at all other times. Following the conclusion of an engineering study, DDOT determined p.m. peak period travel lanes are not needed for vehicular capacity in this section of the roadway. A full-time parking lane would shorten pedestrian crossing distances across North Capitol Street and potentially calm traffic speeds in this section of North Capitol Street. Therefore, the number of travel lanes along northbound North Capitol Street will be reduced from two (2) lanes to one (1) lane at all times from Longfellow Street to McDonald Place. Signs, parking boxes and other markings will be installed to delineate the parking lane.

Figure 1 shows the location of the proposed lane reduction extents.

As part of this project, Bus Stop ID 1002642 at the intersection of Madison Street and North Capitol Street will be removed to improve transit operations. Removal of the bus stop will also facilitate installation of a curb extension pavement markings and provide additional parking spaces.

All comments on this subject matter must be filed in writing by September 13, 2022 (thirty days after the date of this notice) with the District Department of Transportation (DDOT), Project Delivery Administration anticipates initiating implementation of the above-mentioned modifications starting at the end of the thirty days, pending weather conditions
