Re: One-Way Eastbound Conversion of Wyoming Avenue NW and One-Way Westbound Conversion of Kalorama Road NW

Dear Commissioner Clem:

Pursuant to the "Administrative Procedure Amendment Act of 2000" D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

- **One-way eastbound conversion of Wyoming Avenue NW between 19th Street NW and 18th Street NW, with contraflow bike lane**
- **One-way westbound conversion of Kalorama Road NW between Columbia Road Northwest and 18th Street NW, with contraflow bike lane**

Currently, Wyoming Avenue NW permits eastbound and westbound traffic between 19th Street NW and 18th Street NW and Kalorama Road permits eastbound and westbound traffic between Columbia Road and 18th Street NW. As part of the Adams Morgan Circulation Study, DDOT assessed the potential impacts of converting Kalorama Road NW to a full-time one-way westbound operation and Wyoming Avenue NW to a full-time one-way eastbound operation as requested. A contraflow bike lane will be installed on both the roadways to allow cyclists to continue to travel in both eastbound and westbound directions. DDOT determined that such a conversion would not adversely impact traffic operations in the neighborhood. Following the conversion, parking will remain on both sides of both roadways.

Figure 1 shows the location of the one-way conversions and associated signage of Wyoming Avenue NW and Kalorama Road NW in the Adams Morgan neighborhood.

All comments on this subject matter must be filed in writing by November 9, 2022 (thirty days after the date of this notice), with the District Department of Transportation (DDOT), Project Delivery Administration at 250 M Street, SE, Washington, D.C. 20003. DDOT will review and evaluate comments and anticipates initiating implementation of the above-mentioned modifications starting at the end of the thirty business days, pending weather conditions.
