**Re: Installation of All-Way Stop at Intersection of 15<sup>th</sup> and Crittenden Streets NW**

Dear Commissioner Mansaray:

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

- **Installation of All-Way Stop at the intersection of 15<sup>th</sup> and Crittenden Streets NW**

Currently, the intersection of 15<sup>th</sup> and Crittenden Streets NW, is controlled by a stop sign on the 15<sup>th</sup> Street NW approaches. Based on safety concerns expressed by the community, DDOT conducted a traffic study and determined that all-way stop control, whereby all approaches are required to stop at the intersection, is recommended for implementation at the intersection.

**Figure 1** illustrates the proposed signs and markings to be installed or refurbished as part of the intersection improvements.

All comments on this subject matter must be filed in writing by Monday, November 21 (thirty business days after the date of this notice), with the District Department of Transportation (DDOT), Project Delivery Administration at 250 M Street, SE, Washington, D.C. 20003. DDOT will review and evaluate comments and anticipates initiating implementation of the above-mentioned modifications starting at the end of the thirty business days, pending weather conditions.
