Re: Convert the 4600 block of Iowa Avenue NW to one-way southeast bound

Dear Commissioner Mansaray,

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCMR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

- **Convert the 4600 block of Iowa Avenue NW to one-way southeast bound**

This modification is a result of the analysis performed by DDOT in response to neighborhood traffic safety concerns for pedestrians and vehicular traffic. Iowa Avenue NW is currently a two-way street in the 4600 block which runs from Arkansas Avenue NW to 13th Street NW. DDOT is proposing to convert the 4600 block of Iowa Avenue NW to one-way operations in the southeast bound direction to address the problematic angle crash pattern at this location that is a result of limited intersection sight lines due to the intersection geometry as well as traffic queues reaching this intersection from the traffic signal at Arkansas Avenue and 13th Street NW.

The proposed changes would address the safety concerns at the intersection of Arkansas Avenue NW and Iowa Avenue NW by eliminating the conflict between westbound and southbound approaches, with minimal impact to adjacent roadways or access in the area. Additionally, on-street parking will remain on both sides of the roadway in the southeast-bound direction.

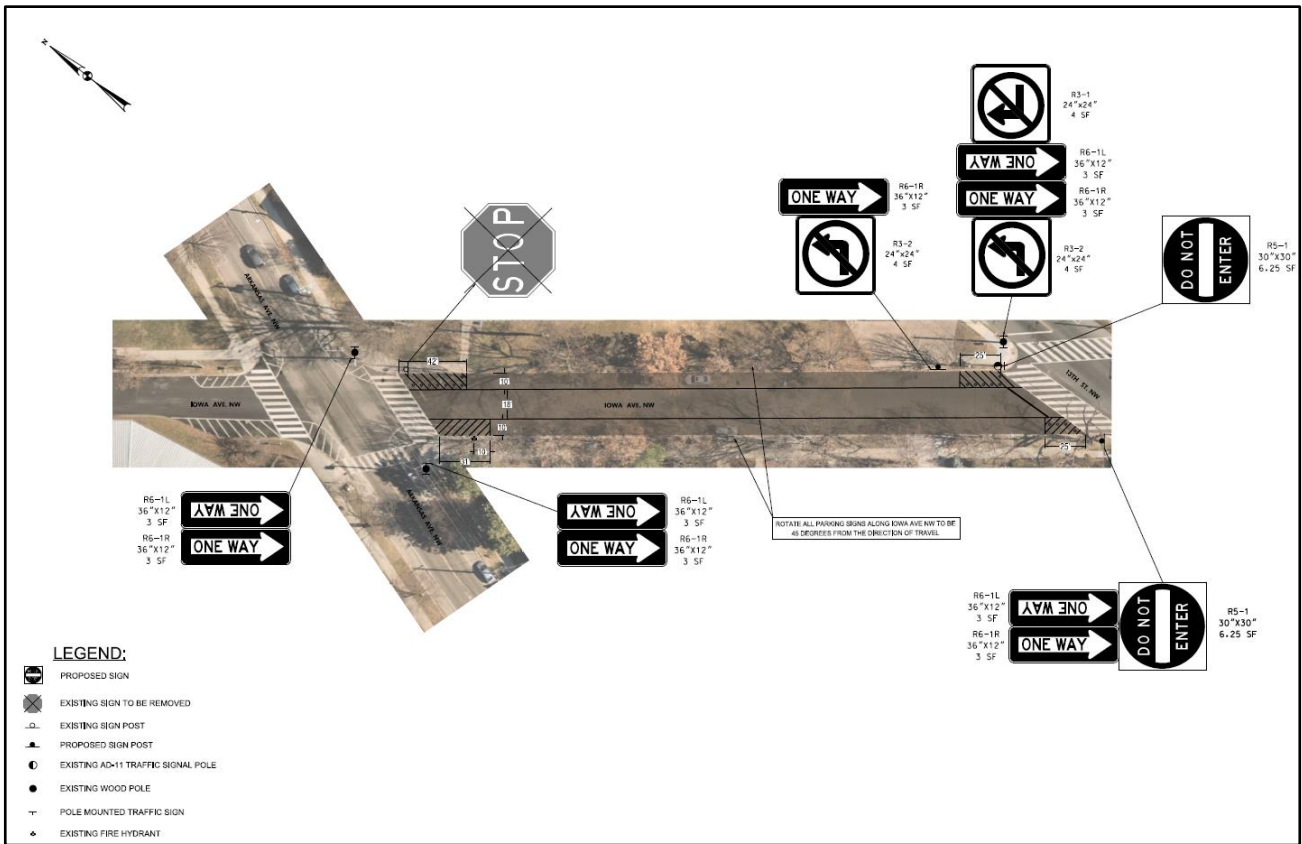


Figure 1: Conceptual Improvements for Conversion of Iowa Avenue to One-Way Southeast-bound from Arkansas Avenue to 13th Street NW

Figure 1 illustrates the proposed improvements in the 4600 block of Iowa Avenue NW.

All comments on this subject matter must be filed in writing by Tuesday, December 13, 2022 (thirty business days after the date of this notice), with the District Department of Transportation (DDOT), Project Delivery Administration at 250 M Street, SE, Washington, D.C. 20003. DDOT will review and evaluate comments and make any necessary adjustments to the intersection following the implementation.
