Re: Motorcoach Loading/Unloading Zone for the 300 Block of 12th Street NW – National Children’s Museum

Chairperson Daniels,

Pursuant to the “Administrative Procedure Amendment Act of 2000” D.C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice of our intent (NOI) to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following in your jurisdiction:

- Conversion of hourly metered parking to Motorcoach Passenger Loading/Unloading Zone

EXECUTIVE SUMMARY

DDOT will install a motorcoach loading zone at the southbound curb in the 300 Block of 12th Street NW. This will remove three (3) hourly metered parking spaces (66 feet of parking space).

DETAIL PROPOSED ACTIONS

The National Children’s Museum requested a safe loading zone for pick-up/drop-off of groups attending the museum on field trip days, 9:30am-4:30pm daily. The museum requested the zone in the 300 block of 12th Street NW at the closest curbside to the museum’s entrance where loading legally can occur.

National Children's Museum serves thousands of educators and students each year through field trips. Located atop Woodrow Wilson Plaza at 13th and Pennsylvania Ave NW, the Museum does not currently have a dedicated loading zone, which has resulted in buses loading illegally on Pennsylvania Avenue NW. An initial site survey with previous DDOT Director Marootian and his team in 2019 determined that 12th Street NW on the west side would be an ideal location for a motorcoach loading zone. The Museum is open from 9:30am - 4:30pm every day of the week except Tuesdays. The loading zone would be most frequented during the school year, August - June, when classrooms will be visiting for field trips. The loading zone can also provide access

to groups visiting the Ronald Reagan Building, International Trade Center, and Federal Triangle Metro Station.

VISUAL AID

This visual aid shows the curbside space that will be redesignated as Metrobus Zone outlined in orange.
