Re: Georgia Avenue and Farragut Street, NW - Traffic Signal Installation NOI-23-56-TESD

Dear Chairperson:

Pursuant to the “Administrative Procedure Amendment Act of 2000” D. C. LAW 13-249 (48 DCR 3491 April 20, 2001), the District Department of Transportation (DDOT) is required to give a written notice to modify traffic and/or parking requirements. This letter is being forwarded to you for the purpose of notification and solicitation of comments on our intent to implement the following modifications in your jurisdiction.

- **Georgia Avenue and Farragut Street, NW**

An independent determination has been made by the DDOT/Traffic Engineering and Safety Division to install and operate a traffic signal at the intersection of Georgia Avenue and Farragut Street, NW. Traffic signal control can provide for the safe and efficient movement of vehicular, bicycle, and pedestrian traffic operating through and in the immediate vicinity of this location. The proposed new traffic signal will be timed to operate in harmony with adjacent traffic signals on Georgia Avenue to minimize disruptions to through traffic.

The proposed improvements also include,

- Construction of ADA ramps
- Improvements to streetlights
- Signs and markings

All comments on this subject matter must be filed in writing or emailed by Wednesday, May 1, 2023 (Thirty business days after the date of this notice), with the District Department of Transportation (DDOT), Traffic Engineering and Safety Division at 250 M Street, SE, Washington, D.C. 20003.
